PRIVACY NOTICE

Gooderstone Water Gardens understand that customers care about the use and storage of their personal information and value your trust in allowing them to do this in a careful and sensible manner. They have created this privacy notice in order to demonstrate their commitment to the privacy of their visitors.

What Information Gooderstone Water Gardens Collects

When you make an enquiry, Gooderstone Water Gardens will collect some of your personal information, to make sure they have everything they need to make the most of their visitor attraction. They use this information for administration of the enquiry you have made.

Who Are Gooderstone Water Gardens

Gooderstone Water Gardens are a visitor attraction in Norfolk who gathers and processes your personal information in accordance with this privacy notice and in compliance with the relevant data protection Regulation and laws. This notice provides you with the necessary information regarding your rights and their obligations, and explains how, why and when they process your personal data.

Information That is Collected

Gooderstone Water Gardens processes your personal information to meet with legal and statutory obligations and to provide you with their services. They will never collect any unnecessary personal data from you and will not process your information in any way, other than as specified in this notice.

The personal data that maybe collected from you is:-

- Address
- Email
- Landline Number

They may collect this information in the following ways

- Email via website
- Personal Email
- Telephone
- In Person
- In Writing

Your personal data is securely stored offsite in a private secure office via a manual work book.

How Will They Use Your Personal Data (*Legal Basis for Processing*)

Gooderstone Water Gardens takes your privacy very seriously and will never disclose, share or sell your data without your consent, unless required to do so by law.

Your Rights

You have the right to access any personal information that Gooderstone Water Gardens processes about you and to request information about:-

- What personal data they hold about you
- The purpose of the processing
- The categories of personal data concerned
- How long they intend to store your personal data for

If you believe that Gooderstone Water Gardens holds any incomplete or inaccurate data about you, you have the right to ask them to correct and/or complete the information and they will strive to do so as quickly as possible; unless there is a valid reason for not doing so, at which point you will be notified.

You also have the right to request erasure of your personal data or to restrict processing in accordance with the data protection laws.

If Gooderstone Water Gardens receives a request from you to exercise any of the above rights, they may ask you to verify your identity before acting on the request; this is to ensure that your data is protected and kept secure.

Sharing and Disclosing Your Personal Information

Gooderstone Water Gardens does not share and or will not disclose any of your personal information without your consent, other than for the purposes specified in this notice or where there is a legal requirement.

Safeguarding Measures

Gooderstone Water Gardens takes your privacy seriously and takes every reasonable measure and precaution to protect and secure your personal data. Gooderstone Water Gardens works hard to protect you and your information from unauthorised access, alteration, disclosure or destruction.

Lodging a Complaint

Gooderstone Water Gardens only processes your personal information in compliance with this privacy notice and in accordance with the relevant data protection laws. If, however you wish to raise a complaint regarding the processing of your personal data or are unsatisfied with how they have handled your information, you have the right to lodge a complaint with the supervisory authority.
